Classes - Divided by Sex

Regular Classes: Jr (6-9), Sr (9-12), (12-18), Canadian Bred, Bred By Exhibitor, Open, Veteran, Specials Only & Sexually Altered.

Non-Regular Classes: Exhibition Only, Brace & Stud Dog **Unofficial Classes:** Stripped Down Class

Obedience Classes: Regular Classes: Novice "A", "B", Open "A" & "B", & Utility Transition Classes: Pre Novice, Novice "C", Intermediate Novice
Unofficial Classes: Graduate Novice, Graduate Open & Veterans.

Note: Dogs entered for the non-regular classes must also be entered in one of the official classes or Exhibition Only.

If entered in non-regular classes, spayed/neutered dogs must also be entered in exhibition only.

Sweepstakes classes (Divided by Sex) Prizes: 25% retained by the club for administration.

Sweepstakes – 6-9 mos, 9-12 mos, 12 – 18 mos., **Veteran Sweepstakes** 7 – 9 yrs, 9-11 yrs, 11 yrs +, as of the day of the specialty.

Best In Sweepstakes - Rosette and 50% of Total entry fees, Best Opposite Sex In Sweepstakes - Rosette and 25% of Total entry fees

Prizes

Through the generosity of members and friends, the American Cocker Spaniel Club of Canada Ontario South Chapter will offer a suitable trophy and/or Rosette, for the following: Best of Breed, Best of Opposite, Best of Winners, Best Puppy in Breed, Winners Male & Female., Reserve Winners Dog & Bitch. All Conformation regular and non-regular classes 1st-4th place will receive a ribbon.

Award of Merit: at the judges' discretion, after the Best of Breed judging, one award of merit will be offered for every ten (10) dogs competing for Best of Breed.

OBEEDIENCE - Class awards All qualifying scores will receive a qualifying ribbon in official classes.

In each official class, a trophy and rosette will be awarded to the 1st. place dog and a rosette will be awarded to the 2nd., 3rd., and 4th. placed dogs. In each transition class, a trophy and "pass" rosette will be awarded to 1st. place dog. A "Pass" rosette will be awarded to all passing competitors in transition classes. In each unofficial class, a trophy and rosette will be awarded to 1st. place dog and a rosette will be awarded to 2nd., 3rd. & 4th. place dogs.

High In Trial - A special rosette and trophy will be awarded for the highest scoring dog in the trial.

Highest Scoring Canadian Champion of Record: A special rosette and trophy will be awarded for the high scoring Canadian Conformation Champion.

On this day SWOSDC will award a trophy for the Highest Scoring Spaniel (Am Cocker) in the Trials

Unofficial Classes - Graduate Novice Class - The Graduate Novice Class is open to any dog of either sex that has not gained a qualifying score toward the C.D.X. title in Canada, but which has obtained the title of C.D. in Canada prior to the closing date of the trial in which it is to be entered. Exhibitors may enter more than 1 dog in this class but must have a separate handler for each dog in the Long Sit and Long Down exercises when they are judged in the same group. The Graduate Novice exercises will be performed and judged as in the official Novice Class, except that the Heel Free with the Figure 8, Drop on Recall, Long Sit and Long Down exercises will be performed and judged as in the official Open Class.

Graduate Open Class - The Graduate Open Class is open to any dog of either sex that has not gained a qualifying score toward the U.D. title in Canada, but which has obtained the title of C.D.X. in Canada prior to the closing date of the trial in which it is to be entered. Exhibitors may enter more than 1 dog in this class but must have a separate handler for each dog in the Long Sit Exercise when they are judged in the same group.

Veteran Class - The Veterans Class shall be for dogs that have an obedience title and are 7 years old on the day of the trial. The exercises shall be performed and judged as in the Novice Class. Dogs entered in the Veterans Class must also be entered in any Regular class or for Exhibition Only.
